Also in 2013, we established operations at the newly opened O'Fallon Park Recreation Center and Twillman Elementary School, giving us the opportunity to help transform the lives of even more youth. Our other sites - Herbert Hoover Club on North Grand; Adams Park Club in the Grove neighborhood; and Southeast Middle School in Spanish Lake, continue to flourish. We introduced the Y-Read program at targeted Mentor St. Louis sites to further promote literacy among elementary age children. We hosted Boys & Girls Clubs of America's (BGCA) first-ever Joint Regional Leadership Conference. BGCA is transforming the youth development space by helping local Clubs deliver proven programs more effectively, with emphasis on professional and resource development practices.

To increase impact, we've challenged ourselves to reach more kids in more locations, and to get them into their Club more often. We have the talent and leadership, an engaged and diverse Board of Directors, and the Great Futures Impact Plan. In other words, we have the capacity to do it!

Since 1967, Boys & Girls Clubs of Greater St. Louis has been providing a safe place for children to learn and grow. BGCSTL now serves nearly 5,700 kids, including 3,422 registered Club members at five sites and within several other schools in the St. Louis region. The Club is open during hours that kids are most likely to need a safe place to go — after school and during summer. Nationally recognized programs led by professional staff are targeted to help youth succeed in school, stay healthy, pursue interests in arts and sports, and explore career choices. Membership fees are kept low to allow any child the opportunity to join and includes free vision and dental care!

We're Making an Impact!

As part of its charitable lineup for the **2013 World Series, Major League Baseball** celebrated the work of the Boys & Girls Clubs of Greater St. Louis, a longtime partner of MLB (through Boys & Girls Clubs of America). Youth of the Year **Amanda Richardson** and Club Member **Eric Davis, Jr.** delivered the first pitch ball to the mound at the last two local games.



The **Boys & Girls Clubs of Greater St. Louis** was selected as one of eleven Clubs nationwide to receive the **"Maytag Dependable Club"** award in recognition for its demonstrated commitment to reliability and dedication to keeping youth on the path to achieve great futures. As part of the celebratory activities surrounding the honor, the **"Maytag Repairman"** made an appearance during the Triple Play Field Day to present two kids from each Club with a Maytag award for good sportsmanship and character.



More than 405 elementary school-age members at five St. Louis Public Schools and all five Club locations received mentoring through the **Mentor St. Louis** program.

During the Boys & Girls Clubs of Greater St. Louis Back-to-School event festivities, special guest and **NBA Washington Wizards star Bradley Beal** hosted a free basketball clinic at Hazelwood Southeast Middle School. Over 115 Club members participated in the skills session and received personal instruction from the star. One of the most popular stations was the one-on-one challenge with the NBA player himself.

Brad's AAU basketball team also donated 100 pairs of Nike basketball shoes. Participants received a glossy autographed photo of Brad and small trinkets courtesy of the NBA and Washington Wizards.



Through the support of the **Taco Bell Foundation for Teens, BGCSTL** implemented an advertising campaign targeted at teens. The billboard and radio campaign positioned the Club as a **"one-stop shop"** for teens to prepare them for college and/or work through the **Graduate to Go: Total Teen Experience program**.





ALL THAT JAZZ

All That Jazz Heroes was held on Saturday, November 9th and was the perfect year end celebration of all that Boys & Girls Clubs of Greater St. Louis has accomplished! Chaired by Ron and Judi Wickline and Walter and Sharon Lamkin, more than 420 guests attended wearing superhero flair to "Be A Hero For A Kid." The event raised \$256,000 to support Educational and Cultural programs, including — Power Hour, Project Learn, Mentor St. Louis, dance, musical theatre and more!

MICROSOFT PARTNERSHIP

In celebration of the **Microsoft** retail store's Grand Opening at the St. Louis Galleria, the Boys & Girls Clubs of Greater St. Louis was awarded a \$250,000 software grant. Dr. Flint Fowler, Club President, was on hand to receive the donation at the store's ribbon-cutting ceremony on June 7. The Microsoft Store's software gift is being used to strengthen inter-agency communication, enhance program offerings, and install reliable, current generation systems for Club member and staff use.



PGA

Club members had an opportunity to participate in the **2013 Senior PGA Championship** events, including the Senior PGA Championship Tour and Career Experience at the Bellerive Country Club: the event kickoff with the PGA America Officials and the PGA Championship Youth Clinic. Members were able to tour the facilities, receive golf instruction from Gateway PGA professionals, participate in fun golf activities and have their photo taken at the 18th hole with a PGA professional who played in the Senior PGA Championship.

WOMEN'S LEADERSHIP CIRCLE

In early April, nearly thirty women joined us for the launch of the **Women's Leadership Circle**. The top priority of this program is to establish the Kids Fund, a scholarship program to help families meet the cost of Club membership. Statistics show that children who participate in structured activities during non-school hours perform better in the classroom and make healthier choices. The Fund will help more kids become Boys & Girls Club Members.



JIM BUTLER'S CHARITY GOLF CLASSIC

What a year it was for the **Jim Butler Charity Golf Classic**! Held on Tuesday, May 7th at Sunset Country Club, the Club hosted a sold out tournament. Golfers enjoyed a beautiful day of golf complete with fun games and course challenges. Chairman Larry Parres and the Golf Committee raised \$179,000 to support Health Programs, including Healthy Habits, Passport to Manhood, and SMART Moves.

TABLE FOR FOUR

The Seventh Annual **Table for Four Luncheon** was led by a stellar team of co-chairs — Rhonda Brandon, JoAnn Shaw and Becky Spurgeon. The afternoon's program included a video featuring our young ladies, followed by a SMART Girls performance of an original song and dance. Amanda Richardson

Amanda Richardson, a member of the Club for three years, was named the Youth of the Year for the Boys & Girls Clubs of Greater St. Louis for 2013, the highest honor a Boys & Girls Club member can receive. The title recognizes outstanding contributions to a member's family, school, community and Boys & Girls Club, as well as personal challenges and obstacles overcome.

At the time she won the honor, Amanda was a 17 year old senior at Beaumont Career and Technical Educational High School where her first semester grades put her on Platinum Honor Roll with a GPA of 3.6. She also served as an intern at Lester's - a popular St. Louis restaurant.

At the Club, Amanda served as Treasurer of the Keystone Club and has participated in SMART Girls activities, because she felt it was a wonderful opportunity to share her story with peers and give them healthy advice. Amanda wants her peers in SMART Girls to be positive leaders and role models for younger female members of the organization. "The Herbert Hoover Club is a place I call home" explains Amanda. "It is a place to get away from all the harmful things that surround me in my community. Any day I'm not at the Club I know that I can potentially face violence, drug deals, robberies, and even death." Consequently, Amanda considers the Club a safe place to learn and grow.

In addition to winning this prestigious title, she received \$2,000 in scholarships from Tupperware, BGCA National Youth of the Year sponsor, and the Missouri Alliance of Boys & Girls Clubs.

When asked to describe how the Youth of the Year program has helped, Amanda said, "This process has been just like what I believe the Boys & Girls Club wants to do for us. I've been encouraged by staff and even my peers. They all have really inspired me and I now I believe in myself, I believe I will be successful." Amanda now works as a member of the BGCSTL Herbert Hoover Club team. Amanda was selected as State Youth of the Year and represented Missouri at the Regional Youth of the Year competition in Chicago.

During the past year, Tayanna has learned to build trusting friendships with staff and seek their guidance when settling disputes with others. Although at times trusting others can still be a struggle, she has worked hard to develop friendships with peers and build stronger bonds with her siblings. She completes her homework assignments and has less behavior issues at school and the Club. During Power Hour she loves to choose books and find a place in the Learning Center to read quietly. SMART Girls has encouraged Tayanna to step out of her comfort zone to trust others, develop meaningful relationships, build better communication skills and develop a positive self-identity and lifestyle.

Justin, a member of the Boys & Girls Clubs of Greater St. Louis - Herbert Hoover Club for the past 3 years, has been an Honor Roll mainstay. He is an eighth grader at Most Holy Trinity Harris where he helps fellow students in first through fifth grades succeed by teaching them chess. A landmark study by Smith and Cage in 2000 showed that students who receive chess instruction scored significantly higher on all measures of academic achievement, including math, spatial analysis and non-verbal reasoning ability. At the Club, Justin can always be found in the Learning Center reading a book or spending countless hours completing homework assignments, school projects and studying. He also teaches Club members the fundamentals of chess or assists them in researching information for class projects on the internet. His positive attitude and leadership in the Club allows him to stand out among his peers. He is a role model for all members of the Club. His determination to succeed and make healthy life choices will ensure that he will achieve academic success and grow into a caring, productive adult.

She was also scheduled every Tuesday to meet with a tutor to work one-on-one to build better study habits. When report cards came out for the beginning of the second semester, Amber proudly showed her report card to staff, peers and other members. Her hard work and focus transformed her failing grades to C's and B's. Although Amber was proud of the progress she made, her goal is to eventually raise her grades to A's and B's so she can attend the high school of her choice. Programs offered in the Education Department at BGCSTL enable youth to foster the necessary skills needed to be proficient in basic educational disciplines.

CLUBS HELP KIDS STAY IN SCHOOL AND IMPROVE THEIR ACADEMIC SUCCESS

Each year, 1 in 4 high school students fails to graduate on time. BE GREAT: Graduate, our dropout prevention initiative, targets communities with high dropout rates. Nationwide, our most utilized program is Power Hour, which provides homework help and tutoring. In 2013, BGCSTL introduced Brain Gain, which helps prevent the summer learning loss that contributes to the alarming achievement gap between low- and high-income youth.

CLUBS HELP TEENS GRADUATE FROM HIGH SCHOOL, PREPARED FOR A GREAT FUTURE

Ensuring that every Club member graduates from high school on time with a solid plan for their future is a top priority for BGCSTL. A variety of high-impact programs support this effort:

- Diplomas to Degrees, a college-readiness program
- CareerLaunch®, introduces young people to the world of work
- Money Matters: Make it Count, a financial literacy program

CLUBS HELP KIDS LEAD HEALTHY LIFESTYLES

Our signature program in this area is Triple Play: A Game Plan for the Mind, Body and Soul, which takes a holistic approach to educating youth about nutrition, fitness and forming healthy relationships. Additionally, the WANNA PLAY™ program encourages youth ages 6 to 12 to increase their overall fitness and health while learning the fundamental skills of baseball and softball.

CLUBS HELP KIDS AVOID RISKY BEHAVIORS

9th-grade Club members are less likely than the national average to engage in risky behaviors such as smoking, drinking and using marijuana. Programs like SMART Girls and Passport to Manhood help kids build self-esteem, treat others with respect, and make good choices.

CLUBS HELP KIDS DEVELOP A STRONG CHARACTER

Our Youth of the Year initiative promotes and celebrates service to Club, community and family; academic performance; moral character; life goals; and poise and public speaking ability.

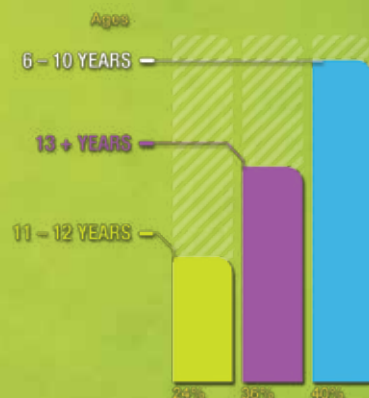
